

DESCRIPTION

This product is specially formulated to remove stains and odors from many surfaces without running or dripping. Unlike liquid spray products, it produces no fallout when applied. It's highly effective on tile, grout, plastic, fiberglass and vinyl surfaces.

CAUTION

DIRECTIONS

SHAKE WELL BEFORE USING.
