Use on finished resilient asphalt, vinyl, rubber and linoleum floors. A routine program will extend the life of the floor finish and help maintain the gloss.

For best results, treat dust mops overnight. Shake out lint and clean mop or cloth in washing machince when finished. Retreat after washing.
